For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, I _____ as parent or legal guardian of _____ a minor (hereinafter "Minor"), hereby grant the permission necessary to allow Minor to participate in the above Event to be conducted by Liberty Cheer Institute, PA Spirit Explosion, and Villanova University. I, in my own behalf and on behalf of the Minor, further agree to release and to hold harmless Releases from any and all liability for negligence or any other claim, judgment, loss, liability, cost and expenses (including, without limitations, attorney's fees and Costs) arising out of or connected with the Event, including any claim arising out of or connected with any illness or injury the at the Minor may incur or sustain during the Event, all activities associated with the Event and while traveling to and from the site for the Event whether or not the Event actually occurs.

I further expressly agree to indemnify and hold harmless Releases and Release's heirs, successors, assigns, executors, and administrators against loss from any further claims, demands or actions that may subsequently be brought by Minor or by any other person or persons on account of damages of any character resulting to Minor in any way from the foregoing activities. I further agree to reimburse and to make good to Releases any loss, damages or costs Releases may have to pay as a result of any such action, claim or demand.
